REPORTS FROM COMMITTEE

CHAIRMAN'S REPORT (Barbara Cannell 864253)

(A Personal View)

Time waits for no man so the saying goes, but I'm sure sometimes we would all wish it might slow down just a little.

I cannot believe that I have been FELHS Chairman for 14 years. During those years the Society has celebrated local and world events, highlighting people and their achievements, whether good or bad, jubilees and disasters. I personally joined on behalf of FELHS other history societies to ring a little of our history to their displays and events. This I have enjoyed doing, often assisted by Jan, and would hope that this might continue but as I say, time marches on.

RESEARCH REPORT (Susan Pittman 01322 669923)(www.felhs.org.uk)

The Windmills of North West Kent and Kentish London

I bought this new book by Rob Cumming (Stenlake Publishing Ltd., £20) at a lecture he gave recently. Local interest lies in the windmill now owned by KCC at West Kingsdown (pp.48-51). This smock mill originally stood near the entrance to Chimhams Farm, close to the appropriately named 'Millfields'. It was shown on the 1819-1820 Ordnance Survey map, and was probably built earlier in the century. One owner, John Hodsoll, became bankrupt and was forced to sell the mill in 1831. It was then described as an excellent mill driving three sets of stone, with dressing and bolting machine, dwelling house, two cottages and 14 acres of land. The mill was taken down and moved to West Kingsdown in 1880. Today it is kept watertight and tarred by KCC, but its sweeps have been removed, leaving bare stocks.

Malting and Malthouses in Kent

This is another new book bought from the author, James Preston (Amberley Books, £14.99). It explains the malting process used to convert barley grain into malt for brewing ale and beer, now no longer practised in Kent. There were once hundreds of malthouses, but now those remaining have been converted into other uses. Half the book is taken up with coloured photographs with some text about each surviving malthouse that James has found in Kent. Both the malthouse in Eynsford (Riverside), an early malthouse dating from the C16th, and in Farningham are featured (pp.43, 45, 59, 60). There is no information about Eynsford malthouse, except reference to Kelly's Directory listing H. Bellingham as maltster in 1859 and 1867, but there is more detail about the C18th malthouse at Farningham , apparently making use of Jane Schoelkopf's article in FELHS publication no.32 (2002), but unfortunately without acknowledgement .

Eynsford Paper Mill one of the oldest

At the Kent Historic Buildings and Industrial Archaeology Conference held by KAS at Sheerness recently, Dr Maureen Green spoke about the history of Hayle Paper Mill, Maidstone. She mentioned 16 pre-1700 paper mills. An attempt was made by John Tate to set up a paper mill in the 1490s, but it failed after his death. Nearly a century was to pass before a German, Johann Spelman, was given licence to open a paper mill on the Darent at Dartford; in 1600 came a paper mill at Buckland near Dover; in 1648 Eynsford paper mill became the third viable paper mill to be set up in the county.

Bad fire at Button Street, 1825

The Rev. Benjamin Sandford (1785-1866) raised an immediate subscription for five labourers whose homes and belongings had been gutted by fire one Saturday. The vicar made no apology for sending out the appeal on the Sabbath as it was in the cause of charity and to help those in most urgent and pressing distress. The response was generous and Rev. Sandford wrote on the reverse side of the appeal, 'By 11 o'clock on Sunday morning the subscription amounted to £32.18.5!!! <u>Well done, Farningham</u>. Farningham for ever! Huzza!!

Eynsford Parish Vestry Minutes 1850-1896

In the days before County and Parish Councils the Vestry ran not only the parish church but the local area. The book begins at about the time Crockenhill All Souls' Church was built, but the village still came under Eynsford Vestry for administrative purposes, and so it included representatives from both communities, who could be non-conformists as well as Anglicans. The Vestry appointed Poor Law Guardian, overseers, assessors (for money raised), and special constables (the following being eligible to serve in February 1851):

27 July 1854

Resolved that a salary of £3.3.0d per annum be paid to Elvy Booker and also to C. Duffell of Crockenhill to perform the following duties viz to prevent all quarrelling and riotous conduct in the street, particularly on the Saturday and Sunday evenings to clear the roads and lanes of all tramps and trespassers, or any other duties required by law.

26 February 1857 - In consequence of the County Constabulary coming in force on 10 March 1857 The Vestry decided it was no longer necessary to pay constables.

18 April **1895** - Sidney Gibson said he had been church warden since 1886, but was a non-conformist, and that since Parish Councils (founded in 1894) had taken over most of the business he felt it only proper that a churchman be selected.

Swanley in Farningham

It is now easily forgotten, or perhaps never known by newer residents, that the parish of Farningham once stretched further west as far as the Co-op petrol garage in Swanley, now well within the area of Swanley Town Council. In 1951 a referendum was held to ascertain the wishes of several hundred residents about whether or not to remain in Farningham. The individual papers show that most wanted to remain in Farningham, but the boundary was moved eastward anyway.

How Farningham fought suburbia in the 1950s

If Farningham residents had been less vocal or articulate developers might well have succeeded in overwhelming the parish with housing. A map of the late 1950s marked 24 sites of development proposals from 1951-1957. Five smaller sites were allowed, but the refusals included development off the High Street near South Hall; development along the east side of Sparepenny Lane from the village almost to opposite Eynsford Paper Mill; development beyond the Lion Hotel up to the roundabout; development on both sides of Eglantine Lane; development along the east and west sides of the A20 past Charton Farm to Speedgate; and development along the east and west sides of the A225 to Calfstock Lane. Farningham Parish Council was robust in its defence of the parish and fought off all these proposals - how different the landscape would have looked otherwise.

Eynsford 2nd World War memorial

The old Church Guide mentioned the lectern with suitable plaque in St Martin's Church, which had been bought for a 2nd World War memorial. I was hoping to record this for the Imperial War Museum when the Church building works had been completed, but it is still inaccessible. However, I came across a letter of July 1946 from Mr Hillier to Eynsford Parish Council requesting, on behalf of Eynsford Toc H, that the memorial cross at the bottom of Bower Lane be so treated as to become a record also of the 2nd World War. He wrote that the Eynsford Branch of Toc H had

looked after the cross since 1931. The first work, with the approval of the Parish Council had been to remove the railings, enlarge and re-turf the plot, and install a new fence. The wych elm had been pollarded, the grass cut, flower beds looked after and the cross scrubbed from time to time, and during the 2nd World War Toc H had paid for armistice wreaths, Christmas garlands, and the general upkeep of the memorial.

Farningham 2nd World War memorial

It seems that it was not until 1956 that Farningham began to make arrangements for a memorial to those who had lost their lives in the war in Farningham. An appeal was made for friends and relatives to submit names. A decision was made to have a tablet in the church, rather than adding names to the 1914-1918 memorial cross in the churchyard. The inscription 'and 1939-1945' was, however, added to the plinth. An estimate for a brass tablet in the church came in at £30, but in the end a stone tablet was ordered from C. Vanston of Dartford for £18.10.0d, for which a faculty was obtained. It was at this time that the parochial church council resolved to vest the war memorial in the churchyard to Farningham Parish Council. The tablet in the church was unveiled on Sunday, 26 October 1957.

Thos.H. Saunders Paper Mill and the Millbourn family

I was contacted by Colin Cohen over FELHS samples of Thos. H. Saunders paper and found that they had been donated by Miriam Millbourn. Colin has been researching Thos. H. Saunders for 40 years so is a real expert. It transpired that the Millbourn family was closely linked to the company in managerial positions, going as far back as the C17th. I put Colin in touch with Carolyn in U.S.A. and all sorts of interesting information has been forthcoming, including notes on the History of the Malt Shovel dictated by Hillier Millbourn to his daughter, Miriam, in 1988. Carolyn has also been researching her Stockley / Millbourn roots and has recently sent some of the fruits of her research to add to FELHS archives. When I have looked closely at both Colin and Carolyn's research I will write more fully in the next Bulletin.

Enquiries

The website contact has recently been out of action and the contact link lost, so it is likely that some enquirers went away disappointed - for this I apologise. I have certainly had fewer queries to answer. The webmaster has now put in another contact on the Contact page so access should be restored.

St Botolph's Lullingstone - Elizabeth wanted to study the church for an M.A. in Historic Conservation. I put her in touch with the Rector so she might look at architectural reports and faculties, and with NADFAS (National Association of Decorative and Fine Arts Society) whose members undertook a detailed study with report in 2002.

FELHS Centre

All the sorted material has been placed at the back of each catalogued folder in the filing cabinets, but the biographical material was so complicated that I have catalogued that section. We owe an immense thanks to the invaluable input of the working parties (comprising Helen, Vikki, Ann, and Alison), who have done a

splendid job sorting material at the Centre. They have also made a preliminary sort of the photographs, which will be continued after Easter. Hopefully, we will gain more volunteers and visitors then. The Society has bought a new electric fan fire so there are now two to heat the Centre up to a comfortable working temperature.

I have spent many hours sorting through the archives of three bodies - Crockenhill Parish Council, Farningham Parish Council and St. Martin's Church, Eynsford. This culminated in a visit to KHLC (Kent History and Library Centre) to deposit nine crates of documents for safe keeping. Documents of lesser importance have been added to FELHS collection, for which we are very grateful.
